WHEREAS, CURRENT OWNER is desirous of obtaining this Confirmatory Worldwide Assignment from ASSIGNOR regarding the INVENTIONS to confirm the ASSIGNOR’s obligation to assign and assignment of INVENTIONS to ALLURE FURNITURE:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, unto ALLURE FURNITURE, its successors, legal representatives and assigns, by way of ASSIGNOR’s employment with ALLURE FURNITURE when the INVENTIONS were created and ASSIGNOR’s obligation to assign INVENTIONS to ALLURE FURNITURE during ASSIGNOR’s employment, and by these presents hereby confirms that ASSIGNOR sold,

assigned, transferred and set over, unto ALLURE FURNITURE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under said INVENTIONS when the INVENTIONS were created and said United States provisional application or said application for United States Letters Patent or said application first filed in a foreign country, as the case may be, and said INVENTIONS in all applications claiming priority thereto or converted therefrom or claiming priority therefrom, and all divisions, renewals, continuations and continuations-in-part thereof, and all Patents of the United States which may be granted thereon and all reissues, reexaminations and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries other than the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said applications above under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof;

ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to ALLURE FURNITURE, its successors, legal representatives and assigns including CURRENT OWNER, in accordance with the terms of this instrument and the Patent Assignment effective October 6, 2020;



ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits and any other papers in connection therewith necessary to perfect such rights, title and interest in ALLURE FURNITURE, its successors, legal representatives and assigns including CURRENT OWNER;

ASSIGNOR further covenants and agrees that ASSIGNOR will communicate to ALLURE FURNITURE, its successors, legal representatives and assigns including CURRENT OWNER, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue, reexamination, foreign applications or other such Letters Patent, make all rightful oaths, and generally do everything possible to aid ALLURE FURNITURE or, its successors, legal representatives and assigns including CURRENT OWNER, to obtain and enforce proper protection for said invention in all countries;

ASSIGNOR hereby authorizes CURRENT OWNER's patent attorney to complete this form by the addition of the application number, application filing date, and attorney docket number, if necessary.
