PATENT ASSIGNMENT

Created To C, LLC, d/b/a Created2C, a Michigan limited liability company, having a registered address of 6040 Stoney Point Drive, Lansing, Michigan 48917 (“**Assignor**”), and Blu Technology, LLC, a Michigan limited liability company, having a principal place of business at 4280 Commercial Ave., Suite 111, Portage, MI 49002 (“**Assignee**”) (collectively, the “**Parties**”), wish to enter into this Patent Assignment (the “**Assignment**”) regarding the patent applications as described in **Exhibit A** attached hereto (the “**Applications**”).

The Parties agree and acknowledge that the aforementioned sale, assignment and transfer shall become effective immediately upon the execution of this Assignment.




