INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this “**Assignment**”) is made, executed and delivered as of August 30, 2019, by and between Cole-Parmer Instrument Company LLC, an Illinois limited liability company (“**Assignee**”) and Zefon International, Inc., a Florida corporation (“**Assignor**”).

WHEREAS, Assignor and Assignee thereto are parties to that certain Asset Purchase Agreement, dated as of August 9, 2019 (the “**Agreement**”), and the Agreement provides for the execution and delivery of this Assignment by Assignor to Assignee;

WHEREAS, Assignor owns all rights, title and interests in and to the intellectual property listed on Schedule I hereto (the “**Intellectual Property**”); and

WHEREAS, Assignee desires to purchase or acquire all of Assignor’s rights, title and interests in and to the Intellectual Property.

NOW, THEREFORE, subject to the terms and conditions of the Agreement and in consideration of Purchase Price as set forth in the Agreement and other good, valuable and sufficient consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee, intending to be legally bound, agree as follows:

1. Assignor does hereby sell, convey, assign, transfer and deliver to Assignee all rights, title and interests of Assignor in and to the Intellectual Property, together with the goodwill and activities of the Business connected with the use of and symbolized by the Intellectual Property and the right to bring suit and recover damages for past, present and future infringement, dilution, misappropriation or violation of any Intellectual Property everywhere in the world, free and clear of all Encumbrances (other than Permitted Encumbrances).

2. Assignor will cooperate to the extent reasonably necessary for Assignee to make any and all required filings to effectuate the assignment and transfer of the Intellectual Property to Assignee.

3. In relation to the domain names identified on Schedule 1 hereto, Assignor agrees to cooperate with Assignee to take all actions and provide to Assignee all items reasonably necessary to initiate and complete the electronic transfer process from Assignor’s account to Assignee’s account, including, without limitation, providing Assignee with the applicable transfer authorization codes to allow Assignee to initiate the process for and effect the online transfer. Assignee shall initiate the transfer of the domain names from Assignor to Assignee with Assignee’s registrar of choice. Within ten (10) Business Days of Assignor’s receipt of a transfer authorization request on behalf of Assignee, Assignor shall authorize such transfer of the domain names to Assignee. Assignor hereby authorizes and requests the applicable registration authority to transfer the domain names from Assignor to Assignee.

4. This Assignment has been executed pursuant to the Agreement and is subject to the terms and conditions thereof. In the event of any conflict or inconsistency between the terms of the Agreement and the terms of this Assignment, the terms of the Agreement shall control.

5. This Assignment shall be binding upon and shall inure to the benefit of the Buyer and the Seller and their respective successors and assigns. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, without giving effect to the conflict of laws rules thereof.

6. This Assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same assignment. Counterpart signature pages to this Assignment may be delivered by facsimile or electronic delivery (i.e., by email of a .pdf signature page) and each such counterpart signature page will constitute an original for all purposes.


