## **ASSIGNMENT AGREEMENT**

WHEREAS, I, **Richard Mellick Zock**, a resident of Lapeer, Michigan (hereinafter "**ASSIGNOR**") have invented certain new and useful improvements in an INTAKE MANIFOLD WITH A BLOW-OFF PRESSURE RELEASE VALVE for which I have filed United States Patent Application No. 17/451,040 in the United States on October 15, 2021 (hereinafter "**the Patent Application**");

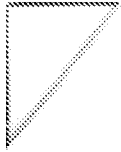
WHEREAS, **Zoom Zoom Parts LLC**, a Michigan limited liability company having offices at 1828 N Saginaw St., Lapeer, MI 48446 (hereinafter "**ASSIGNEE**") desires to purchase the entire right, title, and interest in and to the inventions disclosed in the Patent Application;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby further acknowledges that it has sold, assigned, and transferred, and by these presents does hereby sell, assign, and transfer, unto ASSIGNEE, its successors, legal representatives, and assigns, the entire right, title, and interest throughout the world in, to, and under the said improvements, and the said Patent Application and all Patents that may be granted thereon, and all provisional applications relating thereto (i.e., the provisional patent application titled 'INTAKE MANIFOLD WITH A BLOW-OFF PRESSURE RELEASE VALVE' having a filing date of January 14, 2021 and an application number 63/199,645), and all divisions, continuations, reissues, reexaminations, renewals, and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent that may hereafter be filed for said improvements or for the said Patent Application in any country or countries foreign to the United States; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements and all Letters Patents resulting from the Patent Application to ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this Assignment Agreement.

ASSIGNOR does hereby sell, assign, transfer, and convey to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said issued Letters Patents;

ASSIGNOR hereby covenants and agrees that it will communicate to ASSIGNEE, its successors, legal representatives, and assigns any facts known to ASSIGNOR respecting the Patent Application immediately upon becoming aware of those facts, and that it will testify in any legal proceeding involving any of the Patent Application, will sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and will generally do everything possible to aid ASSIGNEE, its successors, legal representatives, and assigns to obtain and enforce the Patent Application in all countries.

This Assignment expressly includes the conveyance to ASSIGNEES of the right to bring suit for and to collect damages for any infringement (past, present and future) of the Patent, and for a reasonable royalty for any use of 35 USC § 154(d) provisional rights, and for any other cause of action arising from ASSIGNORS' ownership of the Patent, including any violation by others of any federal or state tort or antitrust or unfair competition laws, and in and to any and all reissues, reexaminations and extensions of the Patent, these rights to be held and enjoyed by ASSIGNEES, for its own use and benefit and the use



or benefit of its successors and assigns, to the end of the full term of the Patent, as fully and entirely as the same would have been held and enjoyed by ASSIGNORS, had this Assignment not been made.
