INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT (this "*IP Assignment Agreement*"), is made and entered into effective as of January 26, 2021 ("*Closing Date*"), by and among HOBIE CAT COMPANY, a Missouri corporation ("*Seller*") and HOBIE CAT IP, LLC, a Delaware limited liability company ("*IP Buyer*"). Capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in that certain Asset Purchase and Sale Agreement of even date herewith by and among Seller, Hobie Cat Company II, LLC ("*Buyer*") and IP Buyer ("*Purchase Agreement*").

RECITALS

WHEREAS, pursuant to the Purchase Agreement, Seller has agreed to sell, assign, convey, transfer and deliver to Buyer and IP Buyer, and Buyer and IP Buyer have agreed to purchase and acquire from Seller, all of Seller's right, title and interest in and to substantially all of the assets of Seller, including, without limitation, the Intellectual Property identified in Schedule A hereto (collectively, the "*Seller's Intellectual Property*"); and

NOW THEREFORE, in consideration of the foregoing and the representations, warranties and agreements herein set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller and IP Buyer, intending to be legally bound, hereby agree as follows:

Section 1 Assignment of Intellectual Property. Upon the terms set forth in the Purchase Agreement, Seller hereby sells, assigns, conveys, transfers and delivers to IP Buyer, and IP Buyer hereby purchases and acquires from Seller, free and clear of all Encumbrances except for Permitted Liens, all of Seller's right, title and interest in and to the Seller's Intellectual Property, including, without limitation, all goodwill associated with any trademarks (if any), any and all income, royalties or payments due or payable as of the Closing Date or thereafter as well as the right to sue for any and all past, present and future infringements of such Seller's Intellectual Property, and to receive any and all damages awarded as a result of any such claim, and all other rights and interests therein and thereto ("*Assigned IP*"). In order to enable the use by IP Buyer of the social media accounts and website names and addresses set forth on Schedule A hereto (collectively, "*Domain Names*"), Seller agrees to provide IP Buyer, on the Closing Date, with any account information with any Person with whom the Domain Names are registered, if any, including any user names and passwords of Seller relating thereto.

Section 2 Further Assurances.

(a) Seller hereby covenants and agrees that it shall, at any time after the Closing Date or from time to time thereafter at the reasonable request of IP Buyer, (i) execute and deliver such further instruments of sale, assignment, conveyance, transfer and delivery to IP Buyer as shall be reasonably necessary or appropriate to establish the record of IP Buyer's title to the Assigned IP or to more effectively consummate the assignments contemplated hereby, and (ii) assist IP Buyer, at IP Buyer's request and at IP Buyer's sole cost and expense, in exercising any rights with respect thereto.

(b) Seller authorizes and requests the United States Patent and Trademark Office, the United States Copyright Office and the applicable officials of these and any other agencies or authorities, governmental or otherwise, in which any of the Seller's Intellectual Property listed in Schedule A is or was registered, applied for, pending or recorded, to issue or transfer all of the Seller's Intellectual Property to IP Buyer as assignee of all of Seller's right, title and interest in and to the Seller's Intellectual Property or otherwise as IP Buyer may direct.

(c) As and to the extent that any governmental or quasi-governmental office or agency pertaining to the filing, registration, application or processing of intellectual property, including without limitation the United States Patent and Trademark Office, the United States Copyright Office or the offices in which any of the Seller's Intellectual Property listed in Schedule A is or was registered, applied for, pending or recorded, requests that additional forms or documents be presented or executed by Seller in order to issue or transfer the Seller's Intellectual Property to IP Buyer as contemplated in paragraph (b) of this Section, Seller shall execute such forms and/or documents and deliver them to IP Buyer or its agents, attorneys or designees, as applicable.

Section 3 Successors and Assigns. The terms and provisions of this IP Assignment Agreement shall be binding upon, and inure to the benefit of, Seller and IP Buyer, and each of their respective successors and assigns.

Section 4 Third-Party Beneficiaries. Nothing in this IP Assignment Agreement is intended to or shall confer upon any Person other than the parties and their respective successors and assigns, any rights, benefits, or remedies of any nature whatsoever under or by reason of this IP Assignment Agreement or any transaction contemplated by this IP Assignment Agreement.

Section 5 Choice of Law. This IP Assignment Agreement and the rights and obligations of the parties shall be governed by and shall be enforced and interpreted in accordance with the laws of the State of Delaware, without regard to conflicts of law doctrines.

Section 6 Terms of the Purchase Agreement. Seller and IP Buyer acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby, but shall remain in full force and effect to the extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms and provisions of the Purchase Agreement shall govern.


Section 7 Counterparts. This IP Assignment Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Copies (facsimile, electronic or original) of signatures to this IP Assignment Agreement shall be deemed to be originals and shall be binding to the same extent as original signatures.
