PATENT ASSIGNMENT

This Patent Assignment (the "Assignment") is made and entered into as of the last day of signature below (the "Effective Date") by and between ANDREI ALEXANDRU AMARASTEANU, an individual with an address Strada Maior Sofran No. 18, et2, Apt. 9, Constanta, Romania ("AMARASTEANU") and EBITE, INC., a Delaware corporation with an address 108 West 13th Street, Wilmington, Delaware 19801 ("EBITE") (collectively referred to as the "Parties").

NOW THEREFORE, in consideration of the mutual promises, covenants, warranties and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the Parties agree as follows:

1. AMARASTEANU hereby irrevocably sells, assigns, transfers and sets over to EBITE, AMARASTEANU's entire right, title and interest in and to the Patent, the invention(s) claimed therein, any other patent application directed to the invention(s) claimed therein, and all Letters Patent of the United States that may be granted thereon, and all reissues, reexaminations, and extensions thereof; and all rights to claim priority on the basis of such application, and all applications for Letters Patent that may be filed for the invention in any foreign country and all Letters Patent that may be granted on the invention in any foreign country, and all extensions, renewals, and reissues thereof.
2. Without further consideration, AMARASTEANU agrees to assist EBITE, upon request and at EBITE's expense, by taking any reasonable action that may be necessary for the perfecting, securing, completing, or enforcing EBITE's rights in the Patent.
3. AMARASTEANU hereby authorizes the U.S. Patent and Trademark Office to record and register this Assignment upon request by EBITE.

4. The covenants and conditions contained in this Assignment shall be binding on AMARASTEANU and EBITE and on those who succeed to the interest of AMARASTEANU and EBITE by law, by approved assignment, or by transfer.

5. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, excluding principles of conflicts of laws.
