## TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This Termination and Release of Security Interest in Patents ("Patent Release") is made as of August 29, 2022 by ACF Finco I LP (the "Secured Party") in favor of Clearon Corp. (the "Security Provider").

### W I T N E S S E T H:

WHEREAS, the Security Provider entered into that certain Patent Assignment and Security Agreement, dated as of November 21, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Patent Security Agreement") with the Security Provider, notice of which was recorded on December 19, 2017 at the United States Patent and Trademark Office at Reel 44434, Frame 0797. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.

WHEREAS, pursuant to the Patent Security Agreement, the Security Provider has collaterally assigned, mortgaged, pledged and hypothecated to, and granted for its benefit, first priority liens and security interests in and to, the Secured Party (the "Security Interest") in all of the following property, whether now owned or hereafter acquired or existing by the Security Provider (collectively, the "Patent Collateral"):

(i) all patents and applications for patents now existing anywhere in the world or hereafter adopted or acquired throughout the world, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any foreign country, including each issued patent and patent application referred to in Schedule A attached hereto;

(ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the items described in paragraph (i), immediately above;

(iii) all patent licenses, including each patent license referred to in Schedule B attached hereto; and

(iv) all proceeds of, and rights associated with, all of the foregoing (including license royalties and proceeds of infringement suits), all claims and rights of the Security Provider to sue third parties for past, present or future infringement or dilution of any patent or patent application, including any patent or patent application referred to in Schedule A attached hereto, or for any injury to the goodwill associated with the use of any such patent, and for breach or enforcement of any patent license, including any patent licensed referred to in Schedule B attached hereto, and all rights corresponding thereto throughout the world.

WHEREAS, the Secured Party has agreed to terminate and release its Security Interest in the Patent Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Secured Party hereby agrees as follows:

1. Termination and Release. The Secured Party hereby terminates the Patent Security Agreement and hereby terminates, releases and discharges its Security Interest in all of the Patent Collateral, including the patents listed on Schedule A attached hereto, and reassigns


and transfers to the Security Provider all right, title and interest that the Secured Party may have in the Patent Collateral.

2. Recordation. The Secured Party hereby authorizes the Security Provider, or the Security Provider's authorized representative, to record this Patent Release with the United States Patent and Trademark Office.
3. Further Assurances. The Secured Party hereby agrees to duly execute and deliver to the Security Provider any further documents and to do such other acts that the Security Provider (or its respective agents or designees) reasonably request, in order to confirm this Patent Release and the Security Provider's right, title and interest in the Patent Collateral.
4. Governing Law. THIS PATENT RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS PATENT RELEASE OR THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
