CONFIRMATORY GRANT OF SECURITY INTEREST IN PATENTS**

This RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN PATENTS (this "**Release**") is effective as of the 31st day of August, 2022, by and between:

ROLLEASE ACMEDA PTY LTD (ACN 602 498 395), a company organized under the laws of Australia, having an address of 750 East Main St, Stamford, CT 06902 ("**Assignor**"), and

U.S. BANK NATIONAL ASSOCIATION, having an address of 800 Nicollet Mall – Mail Stop BC-MN-H03Q, Minneapolis, MN 55402 ("**Assignee**").

W I T N E S S E T H:

A. Assignor and Assignee, among others, are parties to that certain Amended and Restated Syndicated Facility Agreement dated as of August 29, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "**Credit Agreement**").

B. Assignor and Assignee, among others, are parties to (i) that certain General Security Deed (All Assets) dated as of August 29, 2018, and (ii) that certain General Security Deed (With Exceptions) dated as of August 29, 2018 (collectively, the "**Australian Security Agreements**").

C. Assignor and Assignee are parties to that certain Confirmatory Grant of Security Interest in Patents made effective as of November 8, 2018, which was recorded with the United States Patent and Trademark Office on November 9, 2018, at Reel 047458, Frame 0107 (the "**Patent Security Agreement**").

D. Assignor has satisfied all of the Obligations under the Credit Agreement and the Secured Obligations under the Australian Security Agreements and requested that Assignee terminate and release its security interests.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions.** All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement or the Australian Security Agreements or the Patent Security Agreement, as the case may be.

2) **Termination and Release of Security Interest.** Assignee hereby terminates, releases, and discharges its security interest in and liens on the Patents listed on Exhibit A hereto, including all divisionals, continuations, continuations-in-part, reissues, reexaminations and all corresponding rights in any jurisdiction throughout the world, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom (collectively, the "**Released Patents**"), and Assignee hereby assigns and transfers to Assignor, without representation, warranty or recourse, all of Assignee's right, title and interest in and to such Released Patents, effective as of the date set forth above.
