Assignor hereby acknowledges that this assignment, being Assignor’s entire right, title and interest in and to said Application, carries with it the right in Assignee to apply for and obtain from competent authorities in all countries of the world any and all patents by attorneys and agents of Assignee’s selection and the right to procure the grant of all such patents to Assignee for its own name as assignee of the entire right, title and interest therein;

AND, Assignor hereby further agrees to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid Application, applications and patents to said Assignee, its successors, assigns and legal representatives, as are necessary and proper to secure patent protection thereon throughout all countries of the world, and to otherwise give full effect to and perfect the rights of the assignee under this Assignment;

AND, Assignor hereby authorizes and requests the Commissioner of Patents of the United States to issue such patents as shall be granted upon said Application or applications based thereon to said Assignee, its successors, assigns, and legal representatives.
