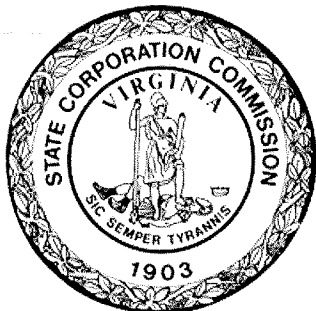

ARTICLES OF CONVERSION

The undersigned, on behalf of the Virginia limited liability company set forth below, pursuant to Title 13.1, Chapter 12, Article 15 of the Code of Virginia, hereby states as follows:

ARTICLE I

The name of the Virginia limited liability company immediately before the filing of these articles of conversion is Cowden Technologies, LLC (the “Company”). The Company shall convert to a Virginia stock corporation and its name shall be Cowden Technologies, Inc.

ARTICLE II

The converting limited liability company was originally organized on December 1, 2015 as a Virginia limited liability company with the name Cowden Technologies, LLC.

ARTICLE III

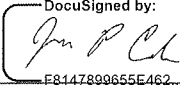
