DOES HEREBY CERTIFY:

FIRST: That by action taken by unanimous written consent of the Board of Directors of Stamps.com Inc. in lieu of a meeting pursuant to Section 141(f) of the General Corporation Law of the State of Delaware and the Bylaws of the corporation, resolutions were duly adopted setting forth a proposed amendment of the Amended and Restated Certificate of Incorporation of the corporation and declaring that such amendment is advisable. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Amended and Restated Certificate of Incorporation of the Corporation be amended by changing Article One thereof to read in its entirety as follows:

“ARTICLE ONE
