- (g) any and all applications for Letters Patent upon said inventions which have heretofore been filed or may hereafter be filed in any and all countries foreign to the United States of America, together with all rights to file and to claim priority in connection with said foreign-filed applications;
- (h) any and all refilings, divisions and continuations of said foreign-filed applications;
- (i) any and all Letters Patent of countries foreign to the United States of America which may issue from the said foreign-filed applications, refilings, divisions and continuations; and
- (j) any and all extensions of, and additions to, said Letters Patent of countries foreign to the United States of America.


