ASSIGNMENT

I, **Michael S. a United State Provisional Application No. 62/124,473 filed December 19, 2014 and all rights of priority in any country of the world deriving from the above-identified International Application.

I hereby authorize and request the competent authorities to grant and to issue any and all such Letters Patent in any country throughout the world to **MASSACHUSETTS INSTITUTE OF TECHNOLOGY** as the assignee of the entire right, title and interest therein, as fully and entirely as the same would have been held and enjoyed by me had this assignment, sale and transfer not been made.

I agree, at any time, upon the request of **MASSACHUSETTS INSTITUTE OF TECHNOLOGY** to execute and to deliver to **MASSACHUSETTS INSTITUTE OF TECHNOLOGY** any additional applications for patents for said inventions and discoveries, or any part or parts thereof, and any applications for patents of confirmation, registration and importation based on any Letters Patent issuing on said inventions, discoveries or applications, and divisions, continuations, renewals, revivals, reissues, reexaminations and extensions thereof.

I further agree, at any time, upon request of **MASSACHUSETTS INSTITUTE OF TECHNOLOGY**, to execute and to deliver to **MASSACHUSETTS INSTITUTE OF TECHNOLOGY**, such additional documents, if any, as are necessary or desirable to secure patent protection on said inventions, discoveries and applications throughout all countries of the world, and otherwise to do what is necessary to give full effect to and to perfect any and all rights of **MASSACHUSETTS INSTITUTE OF TECHNOLOGY**, under this Assignment, including the execution, delivery and procurement of any and all further documents evidencing this assignment, transfer and sale as may be necessary or desirable.

In testimony of which I have hereupon affixed my signature it is my intention that this Assignment instrument be effective, and all rights transferred herein shall be considered to have vested in **MASSACHUSETTS INSTITUTE OF TECHNOLOGY** as from the December 19, 2014 the filing date of the first filed United States Provisional Application No. 62/124,473 from which priority is hereby claimed.
