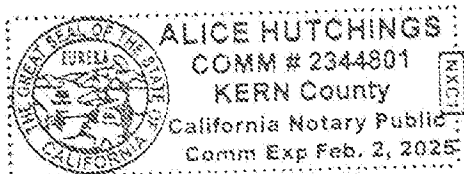



## BILL OF SALE AND ASSIGNMENT
