Pursuant to Section 251 of the General Corporation Law of the State of Delaware (the "DGCL"), Roche Sequencing Solutions, Inc., a Delaware corporation (the "Corporation"), hereby certifies the following information relating to the merger (the "Merger") of Apprise Bio, Inc., a Delaware corporation, with and into the Corporation:

FIRST: The names and state of incorporation of each of the corporations constituent to the Merger are as follows:
