ASSIGNMENT OF PATENT RIGHTS

In addition, Assignor agrees to and hereby does sell, assign, transfer and convey unto Assignee (i) all rights in and to causes of action and enforcement rights for the Patent Rights including all rights to pursue damages, injunctive relief, and other remedies for past and future infringement of the Patent Rights, (ii) the right to apply in any or all countries of the world for patents, certificates of invention, or other governmental grants for the Patent Rights, including without limitation under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperation Treaty, or any other convention, treaty, agreement, or understanding, and (iii) the right to claim for the same the priority rights derived from the patents and patent applications listed in Schedule A under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement, or the domestic laws of the country in which any such application is filed, as may be applicable.

Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention which may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.



The terms and conditions of this Assignment shall inure to the benefit of Assignee, its successors, assigns, and other legal representatives, and shall be binding upon Assignor, its successor, assigns and other legal representatives.
