- (d) the benefit of any agreement or licence for the use of any such right,

and any similar right in any territory or jurisdiction and any applications or right to apply for any of the above together with any registrations, extensions, renewals or applications of or for the same, now or at any time hereafter (and from time to time) owned by the Assignor including without limitation the intellectual property set out in Schedule 1 and including all goodwill in connection therewith;

2 Assignment

In consideration of the payment by the Assignee to the Assignor of the sum of £1 the Assignor hereby assigns whatever right, title and interest (if any) of the Assignor in and to the Intellectual Property.

3 Exclusions of Representations and Warranties

The Assignee admits that the Assignee has inspected and made all investigations it wishes concerning the intellectual Property and the Trade Marks and that the Assignee enters into this Assignment solely as a result of that inspection and investigation and on the basis of the terms of this Assignment and not in reliance upon representations or warranties whether written or oral express or implied made by or on behalf of the Assignor or the Liquidators or their employees or any agents or representatives thereof or any of them.

4 Counterparts

This Agreement may be executed in any number of counterparts and by the parties on separate counterparts, all of which taken together constitute one and the same instrument.

5 Third Party Rights

A person who is not a party to this Agreement has no right to enforce any of its terms under the Contracts (Rights of Third Parties) Act 1999


6 Governing Law and Jurisdiction

6.1 This Agreement is governed by and shall be interpreted in accordance with English Law.

6.2 Each party irrevocably submits to the non-exclusive jurisdiction of the English Courts in relation to all matters arising out of or in connection with this Agreement.






