
8. all rights of priority associated with the **Invention**, applications, patents, and like protection anywhere in the world; and

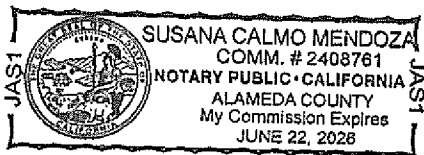
