CONFIRMATORY PATENT ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Party, the Party hereby confirm that:

Effective *nunc pro tunc* as of the Effective Date, the Party do hereby confirm that the Party assigned to MicroSurgical Technology, Inc., and to the extent not previously assigned, do hereby assign to MicroSurgical Technology, Inc., all of the Party’ right, title, and interest in and to the Assigned Patents, including the right to sue for and the remedies resulting from past, present and future infringement of the foregoing, and all rights of protection of interest therein under the laws of all jurisdictions, as fully and entirely as the same would have been held and enjoyed by the Party if the assignment had not been made, including all right, title and interest in and to all income, proceeds, royalties, damages, claims and payments which accrue, or have accrued, prior to and as of the effective date or thereafter and are due or payable with respect thereto, and in and to all causes of action, either at law or in equity for any past, present or future infringement, of the Assigned Patents, or other violation or unauthorized use of the Assigned Patents, with the right to sue for, and collect the same (the “Foregoing Rights”).


2. The Party authorizes and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all Assigned Patents pursuant to this Confirmatory Assignment.

3. The Party acknowledges and agrees that certain documents may need to be executed and delivered by the Party to effectuate transfer of title to the Assigned Patents under this Confirmatory Assignment. The Party agrees to take all further actions, and provide all such cooperation and assistance (including, without limitation, the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation) to more fully and effectively effectuate the purposes of this Confirmatory Assignment.

4. This Confirmatory Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Confirmatory Assignment may not be amended except by an instrument in writing signed by each of the Party hereto.
