FIRST: That the Board of Directors of the Corporation duly adopted a resolution setting forth a proposed amendment to the Fifth Amended and Restated Certificate of Incorporation of the Corporation, and declaring said amendment to be advisable and recommended for approval by the sole stockholder of the Corporation.

- “1. The exact name of the corporation is Azurity Pharmaceuticals, Inc. (hereinafter the “**Corporation**”).”


