**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**

This Termination and Release of Security Interest in Patents (“Release”) is made this 8th day of September 2022, by Highbridge Principal Strategies, LLC, in its capacity as collateral agent (the “Collateral Agent”), in favor of Clean Power Finance, Inc., a Delaware Limited Liability Company, with an address of 222 7th Street, 2nd Floor, San Francisco, CA 94103 (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement by Grantor in favor of Collateral Agent, dated April 7, 2014 (the “Patent Security Agreement”), Grantor granted to Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement);

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on December 17, 2015, at Reel/Frame 037326/0959;

WHEREAS, the Grantor’s obligations under the Credit Agreement and Security Agreement have been satisfied in full and the security interest granted to Collateral Agent pursuant to the Patent Security Agreement has been released by Collateral Agent;

WHEREAS, Collateral Agent has the requisite power and authority to release and discharge its security interest in and to the Patent Collateral; and

WHEREAS, the parties desire to confirm and evidence the termination and release of the security interest in, to and under the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of itself and its successors, legal representatives and assigns, hereby unconditionally, irrevocably, and absolutely (i) terminates the Patent Security Agreement, (ii) assigns to Grantor and its successors and assigns all of Collateral Agent’s right, title and interest (if any) in and to the Patent Collateral and (iii) terminates, cancels, releases and forever discharges any and all security interests it holds in, to, and under the Patent Collateral, including, without limitation, the Patent Collateral set forth on **Exhibit A**.

Collateral Agent shall take all further reasonable actions, and provide to Grantor or its successors, assigns, or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor or its successors, assigns, or other legal representatives to more fully and effectively effectuate the purposes of this Release, in each case, at the sole cost and expense of Grantor or its successors, assigns, or other legal representatives. By this instrument, Collateral Agent authorizes and requests Grantor or its successors, assigns, or other legal representatives to record this Release with the USPTO.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of Delaware.
