AND, for the consideration aforesaid, I hereby authorize and request all officials of the United States Patent and Trademark Office and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said ASSIGNEE as the assignee of our entire right, title and interest in and to such Letters Patent, for the sole use of and possession by ASSIGNEE, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, including any reissues or extensions, as fully and entirely as if such Letters Patent would have been held by ME had this Assignment not been made;
