obtained therefor and thereon, in the United States and throughout the world, together with all rights to sue and bring other claims for past, present and future infringement, misappropriation or other violation of any of the foregoing and all rights to recover damages;

ASSIGNOR HEREBY authorizes and request the Director of the U.S. Patent and Trademark Office or any other proper officer or agency throughout the world to issue any and all letters patent to **ASSIGNEE**.

AND ASSIGNOR HEREBY warrants and covenants that it has full rights to convey the entire right, title and interest herein assigned and that **ASSIGNOR** has not executed and will not execute any instrument or assignment in conflict herewith.

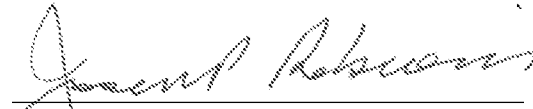

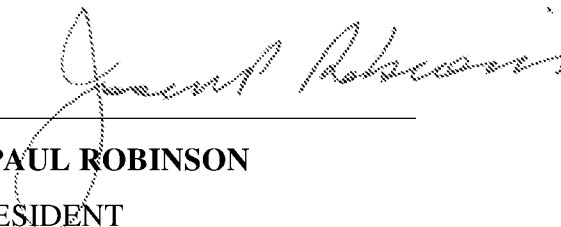
