ASSIGNMENT

This Assignment, made and entered into on Nov 3, 2007 by and between Eldon James Corp. ("Assignor"), and PendoTech, LLC ("Assignee").

RECITALS

1. Assignor and Assignee have developed the following invention which the parties believe to be patentable: provisional application No. 60/810,464 filed 06/03/2006 titled "Disposable pressure sensor for process applications" and related non-provisional application(s) there from (the "Invention").
2. Assignor desires hereby to perpetually assign all right, title and interest in to Assignee for good and valuable consideration as set forth below.

Assignor and Assignee therefore agree as follows:

1. Assignment. Assignor hereby unequivocally and irrevocably assigns, transfers and conveys to Assignee, and Assignee hereby accepts, all right, title, interest, and ownership in and to the invention, and assignor agrees to cause its employee, Dustin Rekow to assign any and all right, title, interest, and ownership in and to the invention to Assignee. Assignor agrees that it shall retain no interest or rights in and to the invention upon the execution of this Assignment.
2. Consideration. As good and valuable consideration for the assignment of the invention to Assignee, Assignee agrees to purchase exclusively from Assignor, and Assignor agrees to sell exclusively to Assignee, Assignee's requirements for products which incorporate the invention, at prices and upon terms to be mutually negotiated and agreed in good faith. This purchase/sale obligation shall continue for the life of any patent covering the invention. If, following a change in control of Assignor, or any assignment of this agreement by Assignor in connection with the sale of all or substantially all of the assets of Assignor related to this Agreement, the parties are unable to agree in good faith upon a price or other terms, Assignee may terminate the purchase/sale obligation.
3. Further Assurances. Assignor agrees to execute or cause to be executed by its employee Dustin Rekow, any further legal documents reasonably requested by Assignee in connection with the perfection of Assignee's ownership of the invention.
4. General.

This Assignment shall be deemed made in the State of New Jersey and shall be interpreted in accordance with the laws thereof.
