The undersigned hereby re-transfers, re-conveys and re-assigns to the Assignor, without recourse, representation or warranty of any kind, any and all right, title or interest that Agent may have obtained in, to and under the Collateral under the Credit Agreement and the Patent Security Agreement.

Capitalized terms used in this Release and not otherwise defined herein have the meanings ascribed to such terms in the Credit Agreement or the Patent Security Agreement, as applicable.

The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby. The Agent hereby authorizes and requests that the United States Patent and Trademark Office record this Release.
