Supplemental Patent Security Agreement

Supplemental Patent Security Agreement, dated as of September 19, 2022, by the entities identified as Grantors on the signature pages hereto (individually, a “Grantor” and, collectively the “Grantors”), in favor of WELLS FARGO TRUST COMPANY, N.A., AS TRUSTEE, in its capacity as collateral agent pursuant to the Guarantee and Collateral Agreement (defined below) (in such capacity, the “Collateral Agent”).

WITNESSETH:

WHEREAS, each of the Grantors is party to the Guarantee and Collateral Agreement, dated as of July 16, 2018, as amended by Amendment No.1 dated as of April 15, 2019 (as so amended and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”) in favor of the Collateral Agent, as Trustee of the CTL 2018-12 Trust (Charter Communications), a special purpose Delaware trust, pursuant to which each of the Grantors is required to execute and deliver this Supplemental Patent Security Agreement;

NOW, THEREFORE, in consideration of the premises, each of the Grantors hereby agrees with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Guarantee and Collateral Agreement and used herein have the meaning given to them in the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest in Patent Collateral. Each of the Grantors hereby pledges and grants to the Collateral Agent for the benefit of the Gateway Beneficial Owners a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral of each Grantor (subject to the last paragraph of Section 3 of the Guarantee and Collateral Agreement, collectively, the “Patent Collateral”):

(a) Patents of each Grantor, including those listed on Schedule I attached hereto;
and

(b) all Proceeds of any and all of the foregoing.

SECTION 3. Guarantee and Collateral Agreement. The security interest granted pursuant to this Supplemental Patent Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Guarantee and Collateral Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Supplemental Patent Security Agreement is deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall control.

SECTION 4. Termination. Upon the payment in full of the Secured Obligations and termination of the Guarantee and Collateral Agreement, the Collateral Agent shall execute, acknowledge, and deliver to each Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Patent Collateral under this Supplemental Patent Security Agreement.

SECTION 5. Counterparts. This Supplemental Patent Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Supplemental Patent Security Agreement by signing and delivering one or more counterparts.




