Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, (the “LLC Act”), ChampionX LLC, a Delaware limited liability company, does hereby certify:

FIRST: That the name and state of formation of each of the constituent entities are as follows:
