Pursuant to Section 18-209 of the Delaware Limited Liability Company Act and Section 264 of the General Corporation Law of the State of Delaware, the undersigned limited liability company, duly formed and existing under and by virtue of the Delaware Limited Liability Company Act, does hereby certify that:

**FIRST:** The name, jurisdiction of formation or organization and type of entity of each of the constituent domestic limited liability companies and other business entities which is to merge is as follows:

**SECOND:** An Agreement and Plan of Merger, dated as of September 12, 2022, by and among, *inter alios*, Compology Inc. and RR Tactical Merger Sub II LLC (the “**Agreement of Merger**”), has been approved, adopted, executed and acknowledged by each of the constituent entities in accordance with the requirements of Section 18-209 of the Delaware Limited Liability Company Act and Section 264 of the General Corporation Law of the State of Delaware.

**THIRD:** The name of the surviving domestic limited liability company is “RR Tactical Merger Sub II LLC” (the “**Surviving Company**”).

**FOURTH:** The certificate of formation of RR Tactical Merger Sub II LLC, as in effect immediately prior to the effective time of the Merger, shall, from and after the effective time of the Merger, be the certificate of formation of the Surviving Company except that such certificate of formation shall be amended to change the name of the Surviving Company to “Compology LLC,” such that Article One of the certificate of formation of RR Tactical Merger Sub II LLC as in effect immediately prior to the effective time of the Merger shall be deleted in its entirety and replaced with the following:

“Article One

The name of the Company is Compology LLC.”

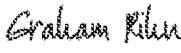
