WHEREAS, on July 25, 2021 (the "Petition Date"), Inshitra Surgical Solutions, Inc. ("Inshitra Surgical"), a corporation organized under the laws of the State of Delaware, previously located and doing business at 141 Hatcher Lane, Clarksville, TN 37043, United States of America, filed a petition under Chapter 11 of the United States Bankruptcy Code,

WHEREAS, the Trustee, acting on behalf of Inshitra Surgical's bankruptcy estate, sold all right, title and interest in and to all intellectual property owned by Inshitra Surgical as of 4th of February 2022 (the "Closing Date"), to Tennessee Medical Innovations Inc., a corporation organized under the laws of the State of Delaware, located and doing business at 141 Hatcher Lane, Clarksville, TN 37043, United States of America, (hereinafter "Assignee"),



Assignor agrees that the Commissioner of Patents and Trademarks may issue any correspondence which may be issued for said Patents and Patent Applications to Assignee, its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said Patents and Patent Applications and the inventions covered thereby that may have been held by the Inshitra Surgical bankruptcy estate as of the Closing Date.
