PATENT ASSIGNMENT

THIS AGREEMENT is made by and between:

WHEREAS, the Assignors have invented certain new and useful improvements, technology, inventions, developments, ideas, ornamental designs, or discoveries (hereinafter the "Work") related to "VENTED CONTAINMENT SKID" (the "Invention") for which a provisional patent application was filed with the United States Patent and Trademark Office on 23 April 2021 having provisional patent application number US 63/178,695 (hereinafter the "Patent Application").

AND WHEREAS, the Assignee wishes to acquire all right, title and interest in and to the Patent Application and the Work, and the Assignor wishes to assign its entire interest in the Patent Application and the Work to Assignee.

NOW THEREFORE, in consideration of mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, and in accordance with applicable law, the Parties hereby agree as follows:

Assignment. Assignor does hereby assign to Assignee, and its successors and representatives, all right, title, and interest in the Patent Application and the Work, including all reexaminations, extensions, continuations, divisionals, continuations-in-part, and reissues thereof, and all worldwide patent applications and patents which derive priority therefrom in any country, and all rights of priority under any International Convention, and any patent or patent application which may hereafter be granted or filed under such international convention.

Payment. In consideration of the assignment of the Patent Application pursuant to this Agreement, and of the promises and covenants contained herein, Assignee shall pay to Assignor a fee in the amount of Ten dollars (\$10.00), payable upon execution of this Agreement.



Further Actions. Assignor hereby agrees to execute any further agreements and to take any further actions necessary to aid Assignee in perfecting its interest in the Patent Application and in enforcing any and all protections or privileges deriving from the Patent Application or any patent claiming priority therefrom. Assignor covenants and agrees that Assignor will communicate to Assignee, its successors, legal representatives and assigns, any facts known to Assignor respecting the Work, assist in preparation of any other patent applications relating to the Patent Application and the Work, testify in any legal proceeding, and generally aid the Assignee, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for the Work in all countries desired by the Assignee.

This Agreement is governed by the laws of the Province of British Columbia and the federal laws of Canada applicable therein.


