I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee. I warrant that, to the best of my knowledge, the rights and property conveyed are free and clear of any encumbrance. At the expense of Assignee, I will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said Technology in all countries. I agree not to subsequently challenge the validity or enforceability of any patents covering said Technology, whether administratively, through the courts, or otherwise.
