FINAL JUDGMENT IN FAVOR OF PLAINTIFF JEFFREY NAN CHANG CHIEN
AND AGAINST DEFENDANTS uREVEAL, INC. AND CHARLES A. CLARKSON

THIS CASE came before the Court on Plaintiff's Motion for Final Judgment. The Court,
having considered the motion, examined the record, and reviewed argument of the parties, is

ORDERED and ADJUDGED that:

1. Plaintiff's Motion for Final Judgment against Defendants is GRANTED.
2. Judgment is entered on Plaintiff's Complaint in favor of Plaintiff Jeffrey Nan Chang Chien, 432 Kennedy Pl., Vernon Hills, IL 60061, and against Defendants uReveal, Inc., 3100 University Blvd. South, Suite 240, Jacksonville, FL 32216, and Charles A. Clarkson, jointly and severally, in the following sums:

a.	Damages:	\$715,750.80
b.	Unpaid Pre-Judgment Interest:	\$ 2,916.92
c.	Total as of 5/9/2022:	\$718,667.73

3. The total sum of \$718,667.73 shall bear interest at the prevailing statutory interest rate of 4.25% per annum from this date through December 31st of this current year, all for which let execution issue, forthwith and instant. Thereafter, on January 1st of each succeeding year

until the judgment is paid, the interest rate will adjust in accordance with Section 55.03, Florida Statutes.

4. Plaintiff, Jeffrey Nan Chang Chien, is deemed to be the prevailing party for the purposes of the Settlement Agreement and Mutual Release entered into between the parties and is therefore entitled to the recovery of his reasonable attorneys' fees and costs from Defendants.

5. Pursuant to Florida Rule of Civil Procedure 1.560, Defendants uReveal, Inc. and Charles A. Clarkson shall each complete, under oath, Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), copies of which are attached hereto as Exhibits A and B respectively, including all required attachments, and serve it on Plaintiff's attorney, or the Plaintiff if the Plaintiff is not represented by an attorney, within 45 days from the date of this Final Judgment, unless the final judgment is satisfied or post-judgment discovery is stayed.

6. Jurisdiction of this case is retained to enter further orders that are proper including, but not limited to, orders awarding attorneys' fees and costs to Plaintiff, orders related to discovery in aid of execution, orders to compel Defendant to complete Form 1.977, including all required attachments, and serve it on Plaintiff's attorney, or Plaintiff if the Plaintiff is not represented by an attorney, and orders to tax any post-judgment fees and costs pursuant to Section 57.115, Florida Statutes.
