ASSIGNMENT BY INVENTORS

- (f) any and all United States and foreign patents which shall issue on said Invention or from any of the above-identified applications ((b) - (e)) including all reissues, reexaminations, renewals, divisions, continuations, and extensions thereof, for the United States, its territories and possessions and all foreign countries, including the right to file applications for Letters Patent on said Invention in any and all foreign countries and any other patent office, the same to be held and enjoyed by said Assignee, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by me, had this Assignment and sale not been made; and further, do sell, assign, transfer and set over unto Assignee, its successors, legal representatives and assigns, the right, authority, and/or permission to: claim priority to, or from, any said Provisional Application (e.g., claim the benefit of the filing date under the Paris Convention) or any other application identified above in (a) - (e), file any of the applications identified above in (b) - (e) in any patent office (or equal) in the world or jurisdiction, be granted any patent (or similar rights) arising from, or issued on, any of the applications identified in (b) - (e), and/or to be granted any patent (or similar rights) identified in (e) above, in any patent office in the world or jurisdiction.

AND for the same consideration, each Assignor hereby represents and warrants to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, each Assignor is a lawful owner of a right, title and interest in and to said Invention and application for Letters Patent above-mentioned, and that the same are unencumbered and that each Assignor has good and full-right and lawful authority to sell and convey the same in the manner herein set forth.




