with its registered seat in Düsseldorf) (business address: ThyssenKrupp Allee 1, 45143 Essen) and on my own notarial deeds I hereby certify:

1. **"thyssenkrupp Elevator AG"** with registered seat in Düsseldorf and business seat in Essen, registered in the Commercial Register of the Local Court of Düsseldorf under HRB 47444, has been renamed into **"thyssenkrupp Elevator Innovation and Operations AG"**. The registered seat, the business seat, the registration and the registration number have remained unchanged. The renaming was registered on December 10, 2019 in the Commercial Register of the Local Court of Düsseldorf and has become valid thereupon.
2. **"thyssenkrupp Elevator Innovation and Operations AG"** has been transformed by changing its legal form from a "Aktiengesellschaft" (a stock corporation) into a "Gesellschaft mit beschränkter Haftung" (limited liability company) named **"thyssenkrupp Elevator Innovation and Operations GmbH"**. The transformation has been registered on June 2, 2020 in the Commercial Register of the Local Court of Düsseldorf and has become valid thereupon. Due to the change of the legal form the register number of the company in the Commercial Register was changed to HRB 89950.
3. **"thyssenkrupp Elevator Innovation and Operations GmbH"** has been renamed to **"TK Elevator Innovation and Operations GmbH"**. The renaming was registered on November 23, 2020 in the Commercial Register of the Local Court of Düsseldorf and has become valid thereupon.
4. Thus **"TK Elevator Innovation and Operations GmbH"**, with business seat in Essen and registered seat in Düsseldorf (Local Court of Düsseldorf, HRB 89950) is legally identical with former **"thyssenkrupp Elevator AG"**, **"thyssenkrupp Elevator Innovation and Operations AG"** and **"thyssenkrupp Elevator Innovation and Operations GmbH"** with business seats in Essen and registered seats in Düsseldorf (Local Court of Düsseldorf, HRB 47444).
