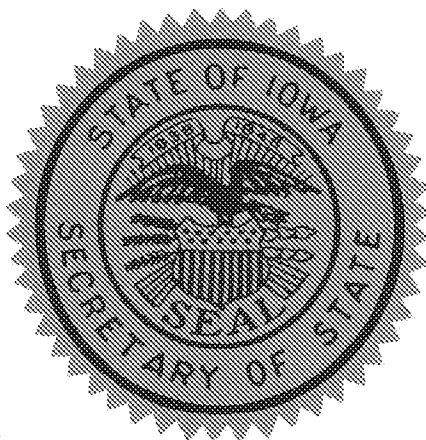

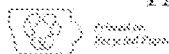


TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 1113 of the Iowa Business Corporation Act and Section 1008 of the Revised Uniform Limited Liability Company Act, the undersigned Corporation adopts the following Articles of Conversion:

1. Compressor Controls Corporation, an Iowa corporation organized on February 5, 1986, has been converted into Compressor Controls LLC, an Iowa limited liability company. The Plan of Conversion (the "Plan of Conversion"), pursuant to which Compressor Controls Corporation has been converted into Compressor Controls LLC effective upon filing, is attached hereto as Exhibit A.
