TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
AND
RELEASE OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY COLLATERAL

This Termination of Intellectual Property Security Agreement and Release of Security Interest in Intellectual Property Collateral (the "Release") is made and entered as of November 1, 2022 by and between SILICON VALLEY BANK, a California banking corporation ("Bank"), and iSIGHT SECURITY, INC., a Texas corporation ("Grantor"), which was merged into FIREEYE, INC., a Delaware corporation, whose name was amended to MANDIANT, INC., as follows:

WITNESSETH

WHEREAS, pursuant to a certain Intellectual Property Security Agreement, dated as of October 24, 2014 by and between Bank and Grantor (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on or about November 20, 2014 at Reel 0342219, Frame 0794, et sec., the Grantor granted the Bank a lien on, and continuing security interest in, all of its right, title and interest in, to and under the "Intellectual Property Collateral" (as defined therein), pledged by the Grantor described therein, including, without limitation, the United States and other patents and trademarks set forth on Schedule A, attached hereto (collectively, the "Patents and Trademarks");

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Bank as of 15 January 2016 ("2016 Termination Date"), and, pursuant to a Pay-Off Letter dated January 14, 2016, entered into by the Bank and Grantor, the Bank granted Grantor a release of the lien and security interest according to its terms and conditions that is being memorized and formalized by this Release; and


WHEREAS, the Grantor has requested, and the Bank has agreed, to terminate the Security Agreement and release the Bank's lien on and security interest in, all right, title and interest in and to the Intellectual Property Collateral in suitable form for government recordation;

NOW, THEREFORE, the Bank, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby memorializes, affirms and restates the termination of the Security Agreement (and any other grant of a lien or security interest to the Bank from the Grantor on the Intellectual Property Collateral) and the termination, cancelation and release of its respective lien on and security interest in the Intellectual Property Collateral, including, without limitation, the Patents and Trademarks, and the goodwill of the business, if any, connected with the use of or symbolized by the Patents and Trademarks, all effective

as of the 2016 Termination Date, and any and all right, title and interest of the Bank in the Intellectual Property Collateral was as of the 2016 Termination Date and shall hereby terminate, cease and become void.

IN WITNESS WHEREOF, the Bank has caused this Release to be executed and delivered by its duly authorized officer as of the date first written above.
