PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT ("**Patent Assignment**"), dated as of November 16, 2022, is made by Innovative Wagering Concepts, LLC (f/k/a G2 Game Design, LLC) ("**G2**"), a Nevada limited liability company, located at 6950 O'Bannon Drive, Las Vegas, NV, 89117, in favor of Albert Massi ("**Massi**"), an individual, located at 3202 West Charleston Blvd, Las Vegas, NV, the acquirer of certain patent assets of G2 pursuant to a Settlement Agreement and Mutual Release between Massi, G2 and other parties, dated as of November 8, 2022 (the "**Settlement Agreement**").

WHEREAS, under the terms of the Settlement Agreement, G2 has conveyed, transferred, and assigned to Massi, among other assets, certain patents and patent applications of G2, and has agreed to execute and deliver this Patent Assignment, for recording with the United States Patent and Trademark Office;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, G2 hereby irrevocably conveys, transfers, and assigns to Massi, and Massi hereby accepts, all of G2's right, title, and interest in and to the following (the "**Assigned Patents**"):

(a) the patents and patent applications set forth in Schedule 1 hereto and any patent application that either has been filed or are awaiting approval or are ready to be filed, that are in any way derivative of, related to, are an expansion of or are continuations in part of US Patent No. 10,210,697 and/or US Patent No. 11,017,637 (the "**Patents**");

(b) all rights of any kind whatsoever of G2 accruing under any of the foregoing Patents provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing Patents; and

(d) any and all claims and causes of action with respect to any of the foregoing Patents, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. G2 hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office to record and register this Patent Assignment upon request by Massi. Following the date hereof, upon Massi's reasonable request, and at Massi's sole cost and expense, G2 shall take such steps and actions, and provide such cooperation and assistance to Massi and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments,

powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Massi, or any assignee or successor thereto.

3. Terms of the Settlement Agreement. The parties hereto acknowledge and agree that this Patent Assignment is entered into pursuant to the Settlement Agreement, to which reference is made for a further statement of the rights and obligations of G2 and Massi with respect to the Assigned Patents. The representations, warranties, covenants, agreements, and indemnities contained in the Settlement Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Settlement Agreement and the terms hereof, the terms of the Settlement Agreement shall govern.

4. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.

5. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law. This Patent Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Patent Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Nevada, without giving effect to any choice or conflict of law provision or rule (whether of the State of Nevada or any other jurisdiction).

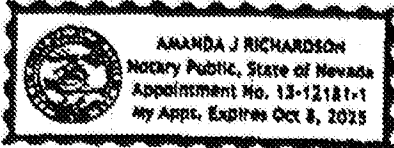

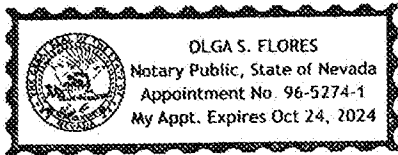
