SHORT-FORM PATENT SECURITY AGREEMENT

WHEREAS, KALIBRATE TECHNOLOGIES LIMITED, a private limited company incorporated and registered in England and Wales (the "Grantor"), has applied for letters patent and has been granted letters patents in the United States Patent and Trademark Office, and is the owner of the patent applications listed in the attached Schedule of Patents and Patent Applications;

WHEREAS, on November 17, 2022 the Grantor entered into that certain Pledge and Security Agreement (the "Security Agreement") in favor of Alter Domus Trustees (UK) Limited, as security agent (the "Security Agent") on behalf of the Secured Parties referenced therein. Pursuant to the terms of the Security Agreement, the Grantor has granted a lien and security interest to the Security Agent, for the benefit of the Secured Parties, in substantially all of the Grantor's personal property, including the Grantor's intellectual property;

WHEREAS, in connection with the Security Agreement, the Grantor is providing this Short-Form Patent Security Agreement for recordation purposes; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby confirms its grant to the Security Agent, to the extent provided in the Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in and Lien (as defined in the Security Agreement) on all of the property described therein, including the patent properties set forth in the Schedule of Patents and Patent Applications attached hereto. In the event of any conflict between this Short-Form Patent Security Agreement and the Security Agreement, the Security Agreement shall control.

This Short-Form Patent Security Agreement may be recorded with the United States Patent and Trademark Office as desired by the Security Agent at its sole cost, expense, and risk.

IN WITNESS WHEREOF, the party hereto has caused this Short-Form Patent Security Agreement to be duly executed and delivered, effective as of November 17, 2022.
