PATENT ASSIGNMENT

FOR AND IN CONSIDERATION of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, SAFE ZONE GLOBAL, INC. (“SZG”), a corporation formerly of the State of California, formerly having a place of business at 31127 Via Collins, Suite 804, Westlake Village, CA 91362 (hereinafter “Assignor”), hereby grants, assigns, sells, transfers, conveys, sets over, quitclaims, and assigns, nunc pro tunc, effective as of February 24, 2015 (hereinafter “the effective date”), to ASPEN SURGICAL PRODUCTS, INC., a corporation of the State of Michigan, having its principal place of business at 6945 Southbelt Drive SE, Caledonia, Michigan 49316 (hereinafter “Assignee”), its successors, the entire rights, title and interests in and to the following United States Patents:

U.S. Patent No. 8,372,503; and
U.S. Patent No. 10,299,825 (collectively hereinafter “SZG Patents”).

NOW, THEREFORE, in consideration of the mutual promises and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SZG hereby agrees as follows:

1. **Assignment.** SZG hereby sells, assigns, and transfers, unto Aspen, as of the Effective Date, and Aspen accepts, the full and exclusive right, title and interest of SZG in and to each of the SZG Patents, including the right to sue for past infringement, in and to any and all divisions, reissues, continuations, continuation-in-part, and extensions thereof, whether pending or issued.

2. **Further Assurances.** SZG further agrees that it shall take such other similar actions as Aspen may reasonably require to effectively assign, convey, and transfer to Aspen the SZG Patents. SZG further agrees to communicate to Aspen or its representatives any facts known to SZG respecting said SZG Patents and to testify in any legal proceeding, sign all lawful papers, and execute all documents related to renewal and/or enforcement of the SZG Patents.

3. **Successors and Assigns.** This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of SZG and Aspen.

4. **Governing Law.** This Assignment shall be governed by and construed in accordance with the substantive law of the State of Michigan without giving effect to the principles of conflicts of law thereof.
