AND THAT ASSIGNORS AGREE, at the request and expense of ASSIGNEE, to perform such proper additional acts, and to execute such additional documents as are deemed necessary by the governmental agencies having jurisdiction over said Patents to effect the transfer of all of the ASSIGNORS' right, title and interest therein to ASSIGNEE, its successors and assigns. In furtherance thereof, ASSIGNORS hereby authorize such governmental agencies to identify ASSIGNEE as the owner of all letters patent issuing from applications pending among said Patents;

AND, ASSIGNORS further represent and warrant that they have the full right to convey the interest assigned by this Assignment, and that they have not granted any rights inconsistent with the rights granted herein.
