

PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (this "Assignment") is entered into as of October 31, 2022 (the "Effective Date"), by and between Cargill, Incorporated, a Delaware corporation ("Cargill") and Pioneer Hi-Bred International, Inc., an Iowa corporation ("Pioneer" and, together with Cargill, the "Parties").

WHEREAS, the Parties entered into that certain Asset Purchase Agreement, dated as of July 19, 2022 (the "**Purchase Agreement**"), pursuant to which Pioneer purchased certain assets used by Cargill in the conduct of the Business (as defined in the Purchase Agreement);

WHEREAS, in connection with the transactions contemplated by the Purchase Agreement, Cargill now desires to assign to Pioneer all of Cargill's right, title and interest in and to the patents and patent applications set forth in <u>Schedule A</u>, attached hereto and incorporated herein by reference (the "Transferred Patents") and Pioneer desires to take assignment and transfer of the Transferred Patents from Cargill and assume the obligations of Cargill related thereto.

NOW THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged, and in consideration of the mutual covenants and undertakings contained in this Assignment, the Parties, intending to be legally bound, covenant and agree as follows:

- Assignment. Cargill hereby sells, conveys, assigns, transfers and delivers to Pioneer, its successors and assigns, Cargill's entire right, title, and interest in and to the Transferred Patents including (1) all provisional, non-provisional, divisional, renewal, substitute, continuation, continuations-in part, international and convention applications based in whole or in part upon aforesaid Patents, and all patents which may be granted thereon and all reissues, reexaminations, and extensions thereof, (2) all applications for patents which may hereafter be filed for said patents in any country or countries, and all patents which may be granted for said applications in any country or countries, (3) the right to have said patents granted in the name of Pioneer, the Commissioner of Patents and Trademarks of the United States of America and any counterpart in any other patent office being hereby authorized to issue or transfer all of said patents to Pioneer in accordance herewith, (4) all proceeds thereof and the rights to sue for past, present and future infringements of the Patents and (5) any right of priority derived from such Patents by virtue of the International Convention for the Protection of Industrial Property and any other treaty or understanding as fully and entirely as the same would have been enjoyed by Cargill, had the Purchase Agreement and this assignment not been made.
- 2. <u>Cooperation</u>. Cargill agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Pioneer to effectuate more fully the transaction contemplated by this Assignment.
- 3. <u>Governing Laws</u>. This Agreement, and all claims or causes of action that are based on, arise out of, or relate to this Agreement, will be governed by and enforced in accordance with the Laws (as defined in the Purchase Agreement) of the State of Delaware without regard to its

conflicts of law rules and any other Law that would cause the application of the Laws (including the statute of limitations) of any jurisdiction other than the State of Delaware.

- 4. <u>Successors and Assigns</u>. This Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns.
- 5. <u>Amendment and Modification; Waiver.</u> This Assignment may be amended, modified or supplemented only by an agreement in writing signed by each Party. No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. Except as otherwise set forth in this Assignment, no failure to exercise, or delay in exercising, any rights, remedy, power or privilege arising from this Assignment shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.
- 6. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
