PATENT ASSIGNMENT

This Patent Assignment (the “**Assignment**”), between T.W. Vending Inc. a Minnesota corporation located at 3329 Casey Street, River Falls, WI 54022 (“**TWV**”), and Three Square Market, Inc., a Wisconsin corporation located at 3329 Casey Street, River Falls, WI 54022 (“**TSM US**”), is dated as of November 28, 2022.

Recitals

- A. TWV is the owner of certain technologies which are the subject of the patents and patent applications listed on Schedule A (the “**Patents**”). These technologies are used by TSM US in connection with its business.
- B. TWV hereby assigns the Patents to TSM US.

Agreement

In consideration of the above recitals, the promises set forth in this Assignment, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby transfers and assigns to Assignee absolutely all its right, title and interest in and to the Patents, including:

- a) all patent applications and/or patents listed in the Patents;
- b) all patents and patent applications (i) to which any of the Patents directly or indirectly claims priority, (ii) for which any of the Patents directly or indirectly forms a basis for priority, and/or (iii) that were co-owned and directly or indirectly incorporate by reference the Patents;
- c) all reissues, reexaminations, renewals, extensions, continuations, divisionals, continuations-in-part, 371 applications, continuing prosecution applications, requests for continuing examinations, registrations, additions and substitutions of any item in any of the foregoing categories (a) and (b);
- d) all foreign patents, patent applications, and counterparts relating to any item in any of the foregoing categories (a) through (c), including, but not limited to, Paris Convention applications, PCT applications, their foreign national application counterparts, additions, continuations, and divisionals thereof, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances, including, but not limited to, all rights under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperation Treaty, and/or any other convention, treaty, agreement, or understanding;
- e) all inventions, invention disclosures, and discoveries described in any item in any of the foregoing categories and all other rights arising out of such inventions, invention

disclosures, and discoveries, and all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents and/or any item in any of the foregoing categories, including, for past, current, and future infringement;

TWV hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any other applicable countries, to record TSM US as the assignee and owner of the Patents.




