RESOLVED FURTHER, that all actions of the officers and agents of the Company prior to the effective date of this written consent in furtherance of the intent and purposes of the foregoing resolutions be, and they hereby are, approved, adopted and ratified in all respects; and

RESOLVED FURTHER, that this written consent be placed in the minute book of the Company with the records of the Company.

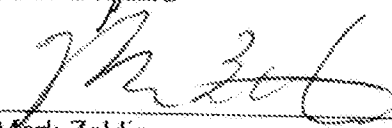
