## TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS dated as of December 16, 2022 (this “Release”), is made by Athyrium Opportunities III Acquisition LP, a Delaware limited partnership, as Administrative Agent (the “Administrative Agent”), in favor of Societal CDMO Gainesville, LLC f/k/a Recro Gainesville LLC, a Massachusetts limited liability company (“Company”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of November 17, 2017 (as the same may be amended, modified, restated or supplemented from time to time, the “Security Agreement”), by and among the Company, the Administrative Agent for the Secured Parties referenced therein, and others party thereto, the Company granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, and continuing lien upon, any and all right, title and interest of Company’s Patents and patent licenses, including those patents, patent licenses and patent applications set forth on Schedule 1 attached hereto (collectively, the “Patent Collateral”); and

**WHEREAS**, pursuant to the Security Agreement, the Company executed and delivered to Administrative Agent the Notice of Grant of Security Interest in Patents dated as of November 17, 2017, which was recorded at the United States Patent and Trademark Office (“USPTO”) on November 17, 2017, at Reel 044165 Frame 0783, and correctively re-recorded at the USPTO on March 8, 2019, at Reel 048540 Frame 0737 (“Notice”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent and Company agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and continuing lien upon, any and all right, title and interest of Company’s Patent Collateral, including those patents, patent licenses and patent applications set forth on Schedule 1 attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Company’s expense.

**SECTION 3. Choice of Law.** This Release and obligations of the parties hereunder, and all of their successors, assigns, and transferees, shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Secured Parties, has caused this Release to be duly executed as of the date first set forth above.
