**CERTIFICATE OF MERGER
MERCING
TINY PRINTS, INC.
WITH AND INTO
HORSLEY ACQUISITION SUB II, LLC**

Horsley Acquisition Sub II, LLC, a limited liability company organized and existing under the Delaware Limited Liability Company Act (the "Act"), does hereby certify that:

FIRST: The name and state of incorporation or formation of each of the constituent entities of the Merger (as defined below) are:

- (a) Tiny Prints, Inc., a Delaware corporation (the "**Transitory Corporation**"). and
- (b) Horsley Acquisition Sub II, LLC, a Delaware limited liability company (the "**Merger Subsidiary**").

SECOND: An Agreement and Plan of Merger, dated as of March 21, 2011 (the "**Merger Agreement**"), by and among the Merger Subsidiary, the Transitory Corporation and certain other parties set forth therein, pursuant to which the Transitory Corporation will merge with and into the Merger Subsidiary (the "**Merger**") immediately following the effectiveness of the First Merger, has been approved, adopted, certified, executed and acknowledged by each of the Transitory Corporation and the Merger Subsidiary in accordance with the requirements of Section 264 of the Delaware General Corporation Law (the "**DGCL**") and Section 18-209 of the Act, as applicable, and by the written consent of the stockholders of the Transitory Corporation in accordance with Section 228 of the DGCL and by the written consent of the sole member of the Merger Subsidiary in accordance with Section 18-302 of the Act. For purposes of this Certificate of Merger, the "**First Merger**" shall mean the merger of Horsley Acquisition Sub I, Inc., a Delaware corporation, with and into Tiny Prints, Inc., a Delaware corporation, Delaware file number 4688910.

THIRD: The surviving entity of the Merger shall be the Merger Subsidiary (the "**Surviving Company**"), and the separate corporate existence of the Transitory Corporation shall cease. The name of the Surviving Company shall be Tiny Prints, LLC.

FOURTH: At the effective time of the Merger, Paragraph 1 of the Certificate of Formation of the Surviving Company shall be amended to read in its entirety as follows:

1. The name of the limited liability company is "Tiny Prints, LLC."

FIFTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Company. The address of said principal place of business is 884 Hermosa Court, Suite 100, Sunnyvale, CA 94085.

SIXTH: An executed copy of the Merger Agreement will be furnished on request and without cost to any stockholder of the Transitory Corporation or the Merger Subsidiary.

SEVENTH: This Certificate of Merger shall be effective upon the filing hereof with the Secretary of State of the State of Delaware, and in no event prior to the effectiveness of the First Merger.
