**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of December 21, 2022 ("Release"), is made by Stellus Capital Investment Corporation, as Administrative Agent ("Agent") in favor of T.F. Hudgins, Incorporated, a Texas corporation ("Obligor").

WHEREAS, pursuant to that certain Security Agreement dated as of October 21, 2016 (as amended, modified, extended or restated from time to time, the "Security Agreement") by and among the Obligor, Agent, and others party thereto, Obligor granted to the Agent, on behalf of the holders of the Debt ("Secured Parties"), a security interest in and a right to set off against all Patents, including the patents and patent applications listed on Schedule A attached hereto (collectively, "Patent Collateral"); and

WHEREAS, pursuant to the Security Agreement, Obligor executed and delivered to Agent the Notice of Grant of Security Interest in Patents recorded at the United States Patent and Trademark Office ("USPTO") on October 24, 2016 at Reel 040260 Frame 0644 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Obligor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in and the right to set off against the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

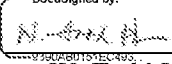
(b) authorizes the recordation of this Release with the USPTO at Obligor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
