ASSIGNMENT OF PATENT RIGHTS



 - (ii) injunctive relief, and
 - (iii) other remedies of any kind for past, current, and future infringement; and
- (e) all rights to collect royalties and other payments under or on account of any of the Patents and/or any item in the foregoing categories (b) through (c).

The terms and conditions of this Assignment of Patent Rights will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignor, its successors, assigns, and other legal representatives.

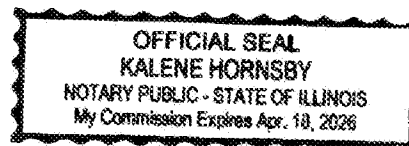
