PATENT ASSIGNMENT

WHEREAS, **ARTIC INVESTMENTS S.A.**, a corporation organized and existing under the laws of **LUXEMBOURG**, and having offices at **65 Rue de la Gare, L-1611 Luxembourg, LUXEMBOURG** (the "Assignor") are the owner of all right, title and interest to the intellectual property rights set out in the schedule to this document (the "RIGHTS") together with the goodwill of the business connected with and symbolized by them;

and WHEREAS, **COMPAGNIE GENERALE DES ETABLISSEMENTS MICHELIN**, a corporation organized and existing under the laws of **France**, and having offices at **23 place des Carmes Déchaux, 63000 Clermont-Ferrand, France** (the "Assignee"), is desirous of acquiring the entire, right, title and interest in and to the intellectual property rights set out in the schedule to this document (the "RIGHTS") and are hereby assigned full title guarantee together with all of rights and interests in respect of the Rights;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to the ASSIGNOR in hand paid, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, ASSIGNOR transfers to ASSIGNEE, its successors and assigns, their entire rights, title, interest in and to the RIGHTS, and corresponding domestic and foreign patent applications (the "Applications"), all Letters Patent, or similar legal protection issuing thereon, and all rights and benefits under any applicable treaty or convention; and

ASSIGNOR authorizes the Commissioner of Patents of any of the states in which the Applications were or will be filed, or foreign equivalent thereof, to issue the Letters Patent, or similar legal protection to the ASSIGNEE ; and

ASSIGNOR authorizes the ASSIGNEE, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, or similar legal protection, in its own name if desired, in any and all foreign countries ; and

ASSIGNOR represents to the ASSIGNEE, its successors and assigns, that they have not and shall not execute any writing or do any act whatsoever conflicting with this Assignment. ASSIGNOR, its executors or administrators, will at any time upon request, without additional consideration, but at the expense of the ASSIGNEE, its successors and assigns, executes such additional writings and do such additional acts as the Assignee, its successors and assigns, may deem desirable to perfect its enjoyment of this grant, and render all assistance in making application for and obtaining, maintaining, and enforcing the letters Patent or similar legal protection on the RIGHTS in any and all countries; and

ASSIGNOR authorizes and requests that any Official of Office of any country or countries, whose duty is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and

ASSIGNOR covenants and agrees that he has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith; and

ASSIGNOR further covenants and agrees that he will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known respecting said RIGHTS, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said RIGHTS in all countries.

ASSIGNEE hereby accepts the assignment.

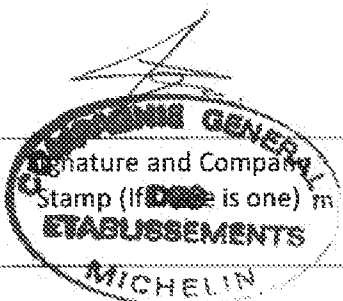
