TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this "Termination"), is dated as of November 11, 2022, and made by and among **BASIC AMERICAN, INC.**, a Delaware corporation (the "Grantor"), and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association ("Wells Fargo"), in its capacity as administrative agent for each member of the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent").

WHEREAS, pursuant to that certain Patent Security Agreement dated as of June 29, 2015, made by the Grantor in favor of Agent (the "Security Agreement"), a security interest was granted by Grantor to Agent in certain collateral, including the Patent Collateral (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded with the patent division of the United States Patent and Trademark Office on June 30, 2015, at Reel/Frame 035958/0630; and

WHEREAS, Agent now desires to terminate and release the Security Agreement.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent hereby states as follows:

1. Definitions. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

2. Termination and Release. Agent hereby:

a. absolutely, unconditionally and irrevocably terminates the Security Agreement, and any other agreement under which the Grantor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, or under the Patent Collateral;

b. absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, hypothecation and lien on, and security interest in and to, the right, title, and interest in, to, and under the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

c. represents and warrants that it has full authority to execute and deliver this Termination; and


d. authorizes the recordation of this Release with the United States Patent and Trademark Office.

3. Further Assurances. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect, confirm or reflect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to the Patent Collateral, Agent will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
