Assignor hereby authorizes and requests the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of the Letters Patent, when granted, to Assignee as the owner of the entire right, title and interest in and to the same, for the sole use and behoof of Assignee, its successors and assigns.




